Govt. Order No. 180-IND of 2018, dated 16.07.2018, Industries & Commerce Department, J&K Government/

Subject: Relaxation of norms for Startups and Micro & Small Enterprises (MSEs) in Public Procurement-suitable amendments in the Industrial Policy-2016.

Ref. No. State Administrative Council Decision No. 20/3/2018, dated 11.07.2018.

Sanction is accorded to the following amendments/insertions in the State Industrial Policy-2016:

1. In para 2.16.1 of the Industrial Policy 2016, the term 'Micro & Small Enterprises' shall be replaced by the term 'Startups, Micro & Small Enterprises';
2. In para 2.16.2 of the Industrial Policy 2016, the term '15%' shall be replaced by '20%';
3. After Section 2.16.2 of Industrial Policy 2016, another Section 2.16.3 shall be read as under:

"Startups, Micro and Small Enterprises registered in the State of J&K shall be exempted of prior experience & turnover clause in all public procurements by State Government/Semi-Government agencies to enable them to participate in the tendering process on an equal platform vis-a-vis experienced entrepreneurs/companies."

It is further ordered that 'SSI Units' would mean 'Startups, Micro & Small Enterprises' at all the places it has been mentioned in the Industrial Policy-2016 and the definition of 'Startup' shall be the same as given in the Scheme-'Setting up of Startup Hub, Incubators and Scheme for Assistance to Startups in J&K', issued vide Govt.
