Creation and establishment of institutions under the constitution is primarily aimed to strengthen the faith and trust of citizens for ensuring justice in accordance with statutory provisions and law. The Constitutional provisions providing for establishment of Public Service Commission (s) are referable to Article 315 to 370 of the Constitution of India and the same are corresponding to Section 128 to 133 of the Constitution of Jammu & Kashmir. So far as coming into force of constitutional body namely Jammu & Kashmir Public Service Commission (J&KPSC) is concerned, it came to be established in the year 1957 and since then, it has evolved into a full-fledge functional authority over the years. There has been a rapid evolution in its mechanism, which deals with the process of recruitment and promotions of persons under gazetted cadres in the government departments. All rules, regulations and guidelines have been amended for its effective functioning in place as on date. For more than six (6) decades, its decision regarding various selections has also come under scrutiny of Hon'ble High Court as well as before the Hon'ble Supreme Court of India. Till date there has been no compact source of information regarding its rules and regulations as well as the case law scrutinizing the selection/appointment made by the J&K Public Service Commission. However, an earnest effort seems to have been made by the author to compile its rules, regulations & notification as well as case laws.

With a sincere hope that the present compendium will prove useful not only to the Hon'ble Judges of the Bench and members of Bar, but also to the Administrative departments, Tribunals and other bodies dealing with recruitment & promotional cases of the officers as well as in various gazetted service of the state.
